

WATS Course Conditions

THESE CONDITIONS OF OPERATION MUST BE READ, UNDERSTOOD AND AGREED TO, PRIOR TO BEING ACCEPTED INTO THE COURSE.

1. Payment must be received prior to being accepted into the course. Once you submit the form on our website, you will have to make the online payment on the payment page.
2. A 5% Transfer fee applies to any transfer received 14 or more working days prior to the date of the nominated Course.
3. A 10% Transfer fee applies to any transfer received 13 working days or less prior to the date of the nominated Course.
4. A 25% Cancellation fee applies to any cancellation received 20 or more working days prior to the date of the nominated Course.
5. A 50% Cancellation fee applies to any cancellation received between 10 to 19 working days prior to the date of the nominated Course.
6. No refund is applicable for any cancellation with 9 or less working days' notice or the failure to attend the course. Any re-booking must be one through the NSW Taxi Council and full booking fees apply. Note: Training days must be completed in consecutive order as each training day is a pre-requisite for the following day.
7. Should an enrollee cancel from a nominated Course, full payment will be required for enrolment into any future course.
8. Should any enrollee Fail to Attend any one day of The Course (including due to medical grounds), the enrollee will be taken from The Course and before assessment can begin will need to complete that part of The Course not already complete, at a future Course. Payment to attend a future course is at the current published fee rate.
9. Should an enrollee fail to attend any one day of The Course, conditions as detailed in Item 7 above are only available for a period of twelve weeks from the date of being removed from the original Course.
10. Should any enrollee fail to re-enroll as detailed in Item 8 above, full payment for enrolment into any future Course will be required.
11. Late attendance will be taken as failing to attend and conditions as detailed in Items 7, 8 and 9 above will apply.
12. One set of all material and teaching aids required by The Course will be supplied. Should any enrollee lose any part of that material or fail to bring that material to The Course as required, to continue in The Course substitute material will need to be purchased by the enrollee.
13. Failure to comply with the conditions of Item 11 above will be taken as "Failure to Attend" and conditions detailed in Items 7, 8 and 9 will apply.

14. Two forms of personal photographic identification are required to be uploaded at the for the application form on NSW Taxi Council website at the time of enrolment. The required forms of identification are:
 - NSW Taxi Drivers Licence
 - Taxi Driver Id/Authority card.
15. Both items of Personal Photographic Identification uploaded at the time of online enrolment, must be presented each day to the facilitator of The Course prior to admittance into The Course.
16. Failure to meet the conditions as detailed in Item 14 above will be taken as “failure to attend” and conditions in Items 7, 8 and 9 will apply.
17. Enrollees must acknowledge the assessment tasks for this course require physical strength and fitness as explained in the WATS course fitness disclosure statement that has been provided on the online application form.
18. Do you have any individual learning needs? If you have individual learning needs, please inform registration staff prior to your scheduled training to allow necessary arrangements to be made.
19. Any participant who arrives late, for any reason, for any section will be removed from the course. There are no exceptions and no refunds
